Adjustment and Change on Securities options

(Effective from March 28, 2024)

Stock splits are scheduled for the underlying securities listed in the appendix effective from April 1, 2024.

In accordance with this, OSE shall adjust the strike prices of option contracts which are based upon these underlying securities, as in the appendix, on March 28, 2024, the date on which trading starts for shares after the stock splits. Furthermore, the adjusted strike prices will be announced after the day session on March 27, 2024.
