(3)"Value" in the columns of "Customers Account", "Members' Account" and "Total" is calculated on basis of initial contract Prices.

(4)"Value" in the columns of "Loans by Securities Finance Co.", "Shares Lent by Members" and "Funds Lent by Members" is calculated on basis of the latest closing prices.
