## Launch of CME Group Petroleum Index Futures

Osaka Exchange, Inc. (OSE) is pleased to announce that we have decided to prepare for launching CME Group Petroleum Index Futures on the go-live date on J-GATE3.0 scheduled in the third quarter of FY2021 and start the public comment process.

\* The launch is subject to the necessary approvals, etc. of the related regulatory authorities.

The CME Group Petroleum Index is an index calculated and distributed by CME Group and it is comprised of three products: NYMEX WTI Crude Oil futures, NYMEX NY Harbor RBOB Gasoline futures, and NYMEX NY Harbor ULSD futures listed on NYMEX.

\* The weighting of each component within the Petroleum Index is set as follows: NYMEX WTI Crude Oil 72%, NYMEX RBOB Gasoline 13% and NYMEX NY Harbor ULSD 15%. The weightings will be reviewed annually.

We expect that the CME Group Petroleum Index Futures will enable individual investors to diversify their portfolios managed in Japanese yen and provide opportunities to hedge their position.
