1. Products Included

Domestic publicly offered ESG bonds (green bonds, social bonds, sustainability bonds, sustainability linked bonds, transition bonds, transition linked bonds)

Private placements and bonds issued outside of Japan may also be included on a voluntary basis.

2. Inclusion Period

Until each bond's maturity date, for bonds whose pricing date is 2016 or later Information on ESG bonds whose pricing date was between 2016 and March 2022 has been transferred by JPX Market Innovation & Research, Inc. (JPXI) from the Japan Securities Dealers Association's list of SDG bonds (https://www.jsda.or.jp/sdgs/hakkou.html), so some of the fields are blank.

Issuer : Name of issuer (this may not be the legal name)

Framework : Link to the framework/use of proceeds, etc.

Reporting : Link to reporting/information on actual allocation of funds, etc.

TSE sector : Sector of the issuer (from TSE's 33 sector classification or "other")

Stock Code : Stock Code of the issuer (5 characters)

Bond name : Name of the bond

Prospectus : Link to prospectus for offering/issuance

Issuance amount : Issuance amount

Currency unit : Currency

Interest rate : Interest rate (in the case of a linked bond or similar, interest rate at the

time of issuance)

Settlement date : Settlement date

Maturity date : Maturity date

Term : Term

Lead managers : Lead managers (underwriters)

Offering format : Offering format (public/private, etc.)

Credit rating : Credit rating (not including outlooks) and the name of the organization

that carried out the rating

Bond label : ESG bond label (green, social, etc.)

Referred guideline : Guidelines referred to in the process of external review

External reviewer : Name of organization that provided the external review

External review : Link to review report, etc. from the external reviewer

Other information : Other information on the bond's characteristics (KPIs and targets in the

case of a linked bond, or whether the bond is a digital bond, etc.)

4. Functions of the ESG Bond List Page

(a) Search function ("詳細検索" button)

Search criteria : Pricing date, settlement date (both From - To), keyword

Refine results : Option to include or exclude issues already past maturity

(b) Download function ("ダウンロード" button)

Download data : All data points listed in 3. above

Format : Excel file

(c) Sort function

Sort by : ISIN code, pricing date, issuer, bond name, term

The sort function is not available for issuance amount, where units may vary, or offering amount, bond label, and external reviewer, where multiple data points may be shown in one cell. Please use the Excel file available through the download function.

5. Update Requests from Issuers

The information shown on the ESG Bond Information Platform is usually provided by our operation partners (mostly securities companies), but we can also take requests from issuers for adding or updating information on their own bonds. In these cases, data will be uploaded by JPXI. We welcome requests to add information which is currently left blank for bonds which were priced before March 2022, or change website URLs, for example.
