

Adjustment and Change on Securities options

(Effective from July 30, 2026)

Stock splits are scheduled for the underlying securities listed in the appendix effective from August 1, 2026.

In accordance with this, OSE shall adjust the strike prices of option contracts which are based upon these underlying securities, as in the appendix, on July 30, 2026, the date on which trading starts for shares after the splits. Furthermore, the adjusted strike prices will be announced after the day session on July 29, 2026.
