This supplement dated 9 February 2023 (the "**Supplement**") to the Base Prospectus dated 16 June 2022 as supplemented on 18 August 2022 and 28 October 2022 (as supplemented, the "**Prospectus**") constitutes a supplement to the Prospectus for the purposes of Article 23(1) of Regulation (EU) 2017/1129 of the European Parliament and of the Council (the "**Prospectus Regulation**") and is prepared in connection with the €10,000,000,000 Euro Medium Term Note Programme (the "**Programme**") established by SpareBank 1 SR-Bank ASA (the "**Issuer**").

This Supplement is supplemental to, and should be read in conjunction with, the Prospectus. Terms defined in the Prospectus have the same meaning when used in this Supplement.

The Issuer accepts responsibility for the information contained in this Supplement. The purpose of this Supplement is to:
