TSE has decided on delisting and designation as Securities to Be Delisted as follows.

### 1. Delisting and Designation as Securities to Be Delisted

Because of this, TSE has decided to delist said stock(s) and has therefore designated them as Securities to Be Delisted.

## Notes

FTGroup CO.,LTD. (hereinafter referred to as the "Company") has disclosed that, subject to approval at its annual general meeting of shareholders, it will become a wholly-owned subsidiary of HIKARI TSUSHIN,INC. through a share exchange.\*

In the event that the share exchange is conducted, the Company's stock will be delisted in accordance with Rule 601, Paragraph 1, Item (13) of the Securities Listing Regulations. Please note that if the delisting date changes from Oct. 1, 2026, we will provide a separate announcement.

\*Under the share exchange, shares of HIKARI TSUSHIN,INC. (Code: 9435, Market Segment: Prime Market) are planned to be delivered to the Company's shareholders.

## 2. Exclusion from Securities in Lieu of Money

Stocks indicated as "Excluded" under "Securities in Lieu of Money" in "(1) Issue Name" above will be excluded from securities in lieu of money for the following items from Jun. 4, 2026 (Thu.) inclusive.

- Customer margin for margin transactions and when-issued transactions
