Overview

- ◆ There has been **feedback** from listed companies that they want to more proactively utilize the List of Companies That Have Disclosed Information as a platform to promote themselves to investors. There has also been **feedback** from institutional investors that they are looking forward to being able to see the aggregated details of each company's efforts side by side in the List of Companies That Have Disclosed Information.
- ◆ To more easily convey each company's efforts to investors, TSE will add the details disclosed in Corporate Governance reports to the List of Companies That Have Disclosed Information.

Request for Action

- ◆ To enable the utilization of the List of Companies That Have Disclosed Information as a platform for promotion to investors, TSE requests that companies **confirm the details disclosed in their Corporate Governance report (red border below) and make revisions** based on the following perspectives.
 - If the details of efforts are disclosed in the Corporate Governance report, is there a summary at the beginning that presents the disclosed details, such as an overview of efforts and major targets that have been set?
 - If the details have been disclosed in a different document, such as one of the timely disclosure materials, has a summary of such material been included in addition to a link to the material?
