## SCB Range Settings for Platts Dubai Crude Oil, Gasoline and Kerosene

Along with the product transfer of rubber, precious metals and agricultural market divisions to Osaka Exchange (OSE) on July 27, 2020, the management of the energy market remaining at Tokyo Commodity Exchange (TOCOM) will also be integrated within OSE's business operations.

Accordingly, at the time of the integration, in order to clarify the operational criteria of SCB ranges for crude oil, a major international commodity, and major related commodities, we decided to set the SCB ranges for Platts Dubai Crude Oil, Gasoline and Kerosene (\*1) based on the settlement prices of Platts Dubai Crude Oil during and after the clearing period of July 27<sup>th</sup>, 2020 as shown below.

- \*1 Except for Gas Oil, Cash-settled gasoline, kerosene and gas oil swaps, and Chukyo Gasoline and Kerosene.
- 1. Setting Method, etc.

(1) Criteria for SCB Range Expansion

① Trigger Criteria (Trigger Conditions) and Range of Expansion

If <u>any one of the contract months</u> of the Platts Dubai Crude Oil settlement prices reaches a Price Range higher than the current Price Range, the <u>SCB Range for all contract months of</u> <u>Platts Dubai Crude Oil, Gasoline and Kerosene</u> will be moved/expanded to the next higher SCB Price Range (please refer to the Appendix).

If/when the SCB range is expanded, the next measurements will start <u>from the clearing</u> period that follows the clearing period where the criteria for trigger (trigger conditions) was met.

② Timing of SCB Range Expansion

From the night session of the second business day after the clearing period during which the settlement price(s) caused the trigger of the expansion.

(2) Criteria for Reduction of SCB Range

① Trigger Criteria (Trigger Condition) and Range of Reduction

If the settlement prices of all the contract months of Platts Dubai Crude Oil fell in the Price Range lower than the current Price Range for <u>five business days in a row</u>, the <u>SCB</u> Range for all the contract months of Platts Dubai Crude Oil, Gasoline and Kerosene will be reduced to the SCB Range for Price Range immediately lower than the Price Range currently in effect (please refer to the Appendix).

# If/when the SCB range is reduced, the next measurements will start <u>from the clearing</u> period following the clearing period during which the criteria for triggering (trigger conditions) was met.

#### ② Timing of SCB Range Reduction

<u>From the night session of the second business day after the clearing period</u> during which the settlement price caused the trigger of the reduction.

If the Price Range of the settlement price of all the contract months of Platts Dubai Crude Oil fell two or more Price Range lower than the current Price Range, or the Price Ranges of contract months fell lower to multiple lower Price Ranges, the SCB Price Range immediately lower than the current Price Range in effect will be applied.

If <u>any one of the contract month settlement price of the Platts Dubai Crude Oil</u> reached the higher Price Range from the Price Range currently in effect, SCB Range for all contract months of Platts Dubai Crude Oil, Gasoline and Kerosene will be expanded.
