
- The month in which the start date of the Interest Rate Reference Period falls is used to indicate the contract month.
- As an example, the trading schedule for the **<u>December</u>** 2021 contract is as follows:
 - ✓ Trading Period: March 15, 2017 (Wed.) through March 15, 2022 (Tue.).
 - ✓ Interest Rate Reference Period: **December 15, 2021 (Wed.)** through March 15, 2022 (Tue.).
 - ✓ The date on which the final settlement price is determined is March 16, 2022 (Wed.).
 - ✓ The final settlement date is March 17, 2022 (Thu.).
