## **JSCC TERMS OF USE AND AGREEMENT FOR MARKIT JSCC SETTLEMENT PRICES**

IMPORTANT-READ THIS JSCC TERMS OF USE AND AGREEMENT (THIS "AGREEMENT") CAREFULLY BEFORE CONTINUING. BY ENTERING OR OTHERWISE ACCEPTING THIS AGREEMENT BY ACCESSING THE MARKIT JSCC SETTLEMENT PRICES, YOU AGREE TO FOLLOW AND BE BOUND BY THE TERMS AND CONDITIONS OF THIS AGREEMENT. IF YOU ARE ENTERING INTO THIS AGREEMENT ON BEHALF OF A COMPANY OR OTHER LEGAL ENTITY, YOU REPRESENT THAT YOU HAVE THE AUTHORITY TO BIND SUCH ENTITY TO THE TERMS AND CONDITIONS OF THIS AGREEMENT AND, IN SUCH EVENT, "YOU" AND "YOUR" AS USED IN THIS AGREEMENT SHALL REFER TO SUCH ENTITY. This Agreement details the terms of a legal agreement between you, Markit Group Limited ("Markit"), and Japan Securities Clearing Corporation ("JSCC"). By accessing the Markit JSCC Settlement Prices, You acknowledge that you have read and understood this Agreement and, having read and understood it, agree that its terms shall be legally binding upon you, in addition to any other terms of use governing your use of the JSCC website. In the event of inconsistency between the two, the terms of this Agreement shall prevail. You also agree to comply with all laws and regulations applicable to the use of the JSCC website, the use of the Internet, and to the activities involved in using the JSCC website. If you do not agree with this Agreement, then you may not view the Markit JSCC Settlement Prices.

### **1. CONTENT**

1.1 USE OF CONTENT. YOU HEREBY AGREE AND ACKNOWLEDGE THAT YOU ARE EXPRESSLY PROHIBITED FROM (I) MAKING AVAILABLE ALL OR ANY PORTION OF THE MARKIT JSCC SETTLEMENT PRICES AVAILABLE TO ANY OTHER PERSON OR ENTITY, EXCEPT AS EXPRESSLY PERMITTED IN THIS AGREEMENT; AND (II) CREATING DERIVATIVE WORKS FROM THE MARKIT JSCC SETTLEMENT PRICES; AND (III) USING THE MARKIT JSCC SETTLEMENT PRICES IN THE PROVISION OF ANY SERVICES TO THIRD PARTIES. 3.2 No Liability. ### **4. Indemnification**

4.1 You will indemnify, defend and hold harmless Markit and JSCC and their respective affiliates, directors, officers, agents employees, successors, and assigns and all Data Providers, and each of their respective affiliates directors, officers, agents, employees, members, partners, successors and assigns ("Indemnitees") from and against any and all losses, liabilities, damages, costs (including reasonable attorneys' fees) and expenses arising as a result of any claims, suits or proceedings brought by any third party against any Indemnitees arising from your use of the Markit JSCC Settlement Prices.

### **5. Violation of This Agreement**

5.1 You agree that the Markit JSCC Settlement Prices are produced by Markit through the application of significant commercial efforts by such entities, and any violation by you of this Agreement will constitute an unlawful and unfair business practice, and will cause irreparable harm to Markit and JSCC, for which monetary damages would be inadequate, and you consent to Markit or JSCC obtaining any injunctive or equitable relief that Markit or JSCC deems necessary or appropriate in such circumstances. You agree that neither Markit nor JSCC will be liable to you or to any third party for termination of your access to the Markit JSCC Settlement Prices as a result of any threatened, suspected or actual violation of this Agreement by you.

### **6. General**

6.1 Variation to this Agreement. Each of Markit and JSCC reserve the right to make changes to this Agreement at any time. Your use of the JSCC website and the Markit JSCC Settlement Prices following any change in this Agreement made available to you will constitute your agreement to be bound by the revised Agreement terms.

6.2 Relationship between the Parties. There is no joint venture, partnership, agency or fiduciary relationship existing between the parties and the parties do not intend to create any such relationship by this Agreement.

6.3 Invalidity. This Agreement is the entire understanding and agreement between you and Markit and JSCC with respect to the subject matter herein. If any provision in or any part of this Agreement shall be found to be illegal or unenforceable under any enactment or rule of law then that provision or part shall to that extent be deemed not to form part of this Agreement and the remaining provisions shall continue in full force and effect.

6.4 Governing Law. Your access to and use of Markit JSCC Settlement Prices is governed by and will be construed in accordance with laws of England and Wales, without regard to the principles of conflicts of laws of other jurisdictions. Each party submits to the exclusive jurisdiction of the courts of England and Wales, United Kingdom, for the purposes of determining any dispute arising out of this Agreement, its construction or the transactions contemplated by it.
