(2)東証に直接新規上場する会社が上場の際に行う公募は集計対象とした。
(3)「優先株・転換社債型新株予約権付社債の株式転換等」及び「新株予約権の権利行使」の件数は、月間は延べ会社数、年間は同一会社の実施分は1件とした。後配株式の転換分を含む。なお、新株式が発行されずに、自己株式が付与される場合は集計対象外とした。
(4)第三者割当等は、特定投資家私募を含む。
(5)会社合併等は、合併・買収、その他の組織再編に伴い株式数が増減したものを集計対象とした。

Notes: (1)The base date is the payment date for share allocations, public offerings, and allocations to a third party, the conversion date for preferred stock, and the exercise date for convertible bonds and warrants. The aggregate number of shares issued by all companies on the TSE as of the date is calculated.
(2)Public offerings made when companies list directly on the TSE are included in calculation.
(3)Number of cases for (d) and (e) are monthly aggregates. Annual figures are number of companies. Figures include those for deferred stocks. Figures in “Subscription warrants and Stock Options Exercised” exclude cases where treasury stocks are allotted in accordance with the exercise without issuing new shares.
(4)“Third Party Allotment” includes private placement to specified investors.
(5)“Mergers” includes merger by acquisition and the change in the corporate structures, which entail change of outstanding shares.
